Report technical mission of Bornem delegation

concerning city-to-city cooperation



To Nquthu local municipality/Umzinyathi District Municipality

Monday 30⁻ of November until Thursday10⁻ of December 2009

1. Introduction

After the reciprocal visit from 16th until the 27th of June 2009 an action plan for the next years of co-operation was finalised and summarized in an addendum of the memorandum. This addendum mentioned a technical mission at the end of 2009 focusing on environmental management (certain section), environmental education, GIS (if possible) and technical support in the water- and sanitationproject of Umzinyathi district (by an independent expert from engineers without frontiers or ex-change).

The technical mission of a delegation of Bornem took place from Monday 30th of November until 10th of December 2009 and followed generally the guidelines of the addendum. The delegation of Bornem consisted of 5 members:

- Mr. Dirk Hoofd: exco member of Bornem municipality and responsible for environment, agriculture and civil affairs;
- Mr. Roland Deurinck: head of the environmental service of Bornem municipality and manager technical affairs;
- Mr. Stefan Dekeyser: staff member of the youth service (youth desk) of Bornem municipality;
- Ms. Anneleen Van Tendeloo: staff member Igemo, intermunicipal organisation, related to waste prevention and waste sensitization;
- Mr. Daan Sanders: official north-south relations or development cooperation of Bornem municipality

2. Preparation of the technical mission in Bornem municipality and Nquthu LM/Umzinyathi DM

To prepare this technical mission and enhance further steps forwards towards an implementation, the following steps were taken from the side of Bornem and Nguthu LM:

- Visit of the official North South relations of Bornem municipality, Daan Sanders, in September 2009 linked to his vacation (report of this visit annex nr. 1);
- 4 meetings of the Bornem delegation whereby the terms of reference of the technical mission were prepared;
- o Terms of reference from the side of Bornem delegation (annex nr. 2)
- Different meetings with stakeholders in Nquthu LM concerning the technical mission;
- o Program proposal en definitive program of the technical mission (annex nr. 3);
- Intense contact between the two coordinators of the city to city cooperation: Daan Sanders and Mpume Jiyane (director LED and planning Nquthu LM).

3. Meetings and field visits with for the city-to-city cooperation relevant stakeholders in South Africa and step forwards (*to do*) in 2010-2011, related to the policy fields of cooperation

3.1. Introduction and communication

The arrival of our flight to OR Tambo Airport in Johannesburg was at the Tuesday the 1st of December at 1.30 PM South African time. This gave us the opportunity to drive the same day to Nquthu (5 hours drive from Jo'burg) the same day.

During our whole stay we were lodged in the Arusha Lodge in Dundee, capital of Umzinyathi DM and on 40 minutes driving distance of Nquthu town.

The 8th of December in the late afternoon we left Dundee and Nquthu to drive back to Jo'burg where we had on the 9th of December two more meetings and wherefrom we flew back the same day at 10 PM. We landed in Brussels Airport the 10th of December around 1PM.

We mainly focused our stay, meetings and visits in and around Nquthu and Dundee but on Monday the 7th of December we had meetings and field visits in and around Pietermaritzburg related to ecoschools, library and FET-college. On Wednesday the 9th of December we finalized our trip with 2 meetings in Jo'burg, one concerning youth policy in Ipeleleng youth centre in Soweto and one concerning small scaled but contextually related energy saving projects with Nova Institute of the University of Pretoria in Melville (Jo'burg). During our stay in South Africa we only had few moments of leisure time in the weekend, namely on Sunday afternoon the 6th of December.

When it comes to policy fields that were handled during the technical mission, we can categorise them into:

- o Libraries
- o Ecoschool or environmental education in schools
- o Waste management and awareness
- o Youth
- o Water and sanitation
- o LED and tourism
- o GIS

Within the different sections there is always a budget for 2010 from the side of Bornem municipality integrated. This budget is divided into:

- o Own financial means of Bornem municipality
- o Grants from higher Flemish government which are subdivided into:
 - capacity building (further abbreviated as CA): which can include training, small infrastructure or material costs (based on a policy area of cooperation and a project) and in smaller amounts transport and translation costs
 - o travelling and accommodation costs (further abbreviated as TRAV): which can include flight tickets, passport, visa and accommodation
 - o sensitization (further abbreviated as SE): awareness in a broader sense

At the end of each section budget for 2010 is indicated with the abbreviations and a brief explanation.

Concerning communication we first of all had contact with many stakeholders during the technical mission. These direct and indirect stakeholders with contacts are integrated in the report in the different thematical sections, except the coordinating persons which are mentioned under here.

When it comes to communication in the implementation of the cooperation on the different policy areas, it is crucial to strengthen and to structure the communication:

- **Practical details** on general exchanges will stay the responsibility of the two C2C cooperation coordinators: Mr. Mpume Jiyane and Mr. Daan Sanders
- Supervision from the side of Bornem municipality towards Nquthu LM by e-mail: put Mr. Daan Sanders, Mr. Mpume Jiyane and MM Mr. Paul Gumbi in CC.
- Supervision from the side of Nquthu LM and other stakeholders around Nquthu LM on communication towards Bornem municipality: communicate first towards Mr. Mpume Jiyane, MM Mr. Paul Gumbi and the responsible manager when it comes to formal documents!! If the formal document needs to be communicated urgently: mentioning deadline in subjectfield of e-mail or directly to the responsible persons. No response in time means approval.
- Non formal communication is possible directly between colleagues and stakeholders of both sides when no formal documents are involved.
- Other stakeholders: direct communication is possible but taking into account the internal procedures

3.2. Library

3.2.1. Preparation

In the memorandum of partnership and cooperation which was signed in October 2008, library and also other organisations like schools, cbo's, ... were launched as a key medium which could be a surplus value for different policy fields of cooperation as youth, environment and LED.

During the reciprocal visit in June 2009 both partners decided to also include the exchange of skills and information on library itself into the addendum which was signed at the end of this visit.

The short visit of Daan Sanders in September 2009 made it possible to start up already the communication between the two library managers. Additional questions were posed from the side of Bornem and proposals for further cooperation (see annex nr. 4). As there was already good communication between the two library managers before the technical mission, a participation of the library manager of Bornem to Nquthu LM during the technical mission was not necessary.

3.2.2. Meetings and field visits

On Thursdayevening the 3rd of December there was a meeting with the library manager Mr. Bhekie Magwaza, municipal manager Mr. Gumbi, Mr. Mpume Jiyane and Daan Sanders concerning the library cooperation:

- Proposal of the possible fields of cooperation when it comes to library and jobshadowing in March of the library manager (annex 4). The jobshadowing will fall into the IT week in the library and the youth library week both in March. The jobshadowing or training opens perspectives for a pilote project in 2010 in the Flemish program and a follow up of the start by our library manager in September during the youth exchange. A program draft made by the library team in Bornem is included in this report (annex nr. 5);
- The library can also be used as a medium for other policy field programs like the ecoschool exchange and the communication by blog. It brings the involved schools and pupils into the library though the practical organization of this is not easy due to the large amounts of pupils per class. A selection of pupils of the ecoschool committee with the teachers can bring a solution;
- Presentation of the federal program and possibility to step into it (annex nr. 6) in 2011-2012 for 2 years focusing on mobile or decentralised library hubs in schools or in traditional wards with focus on children and youth;
 - The decision and confirmation concerning intake in the federal program depends on the progression that will be made from January until the jobshadowing in March;
 - Their needs to be a preparation from the side of Nquthu before the arrival when it comes to participation and integration into IDP sessions, and negotiations with the department of education and the department of arts and culture of the KzN province before the jobshadowing;
 - If both partners decide to step into the program, a general concept needs to be in place before the mission to Bornem. A support of the managementteam during this mission to work out the logic framework of the plan, is appropriate.

At Monday the 7th of December during our daytrip to Pietermaritzburg, administrative capital of the KzN province, Mr. Daan Sanders and libary manager Mr. Bhekie Magwaza, had a 2,5h meeting with Golly Odendael and Patricia of the department of arts and culture section of library. The meeting consisted of:

- o Presentation of the department and their competencies and workfields;
 - On the national level: no national library though their is Liassa, the advocacy organisation of libraries at national level
 - o Provincial level:
 - Falls under the department of arts and culture: have their own policies under provincial funds and in smaller amount national grants

- Create still new libraries and programs in existing libraries in KzN province
- Guidance of libraries within KzN province
- Organogram:
 - Department manager: mr. Khumalo;
 - managers of the different sections of arts and culture: Carol Slater for library affairs
 - assistant managers that oversee the depots (5) where the exchange collections are stocked
 - different services within the library section of the department
- o Local municipalities:
 - Library manager is the key player of the library affairs in the LM, with support of the LM;
 - The LM is in charge of paying salaries to the staff and maintainance of the librarybuildings;
 - In Nquthu LM despite the rural character, is Nondweni/Nquthu are one of the pilote libraries in the KzN province and has potential to grow further
- o IT/computerisation projects in the libraries of KzN:
 - Bringing IT to the library is not only a goal (teaching people technology) but also a mean to bring more people and especially youngsters to the library and therefore a marketing project for libraries, linked to empowerment of the community;
 - o Project of cyber cadets:
 - Launched in 2008 for 3 years in 20 hubs where a minimum of 5 pc's and 1 cyber pc has been installed. Connectivity to the world wide web is secured through satellite (which has been the case in Nquthu and Nondweni) or broadband.
 - Cyber cadets give training of computer skills to community members and more specific to youth and women related to employment search and to training related to officesoftware and use of the internet/gmail.
 - 3 years project with possibility of an extension for 3 more years (2011-2013) related to the integration of this program into IDP's and organogram to bring sustainability.
 - cybercadets have a 1 year contract which is renewable.
 - good communication between the cybercadets through a google forum: very important to learn from eachother: some cadets are IT strong, some of them have a lot of capacities when it comes to community work or software. A problem which appeared/can appear depending on the willingness of the library manager and his staff are clear arrangements of responsibility and tasks between staff and the cadets.

- monitoring and evaluation is another strength: every month a report of the cadets is expected.
- plan for next working year: 5 new libraries will step in and upgrading of the existing projects through integration of prints, scanners, cartridge and related softwaretraining (photo's), playing and learning to children through computer
- Other project examples from the department linked to different libraries in KzN:
 - o SMME assistance in the library;
 - Oral history project and family tree projects in synergy with archive section of the department;
 - o Community gardens
- o Presentation of the proposal on mobile or decentralised libraries in Nguthu LM:
 - o Short presentation of the federal program opportunities in 2011-2012;
 - Mobile library concept at the department is in an initial study stage in the KzN province due to priorities and policy choices for so far, though there are many different concepts possible: a few examples
 - Idea of transport units on battery power which can transport people from library to library: 2-4-6-8 people. The only real threat is competition with taxi transport (taxi war);
 - Idea of a donkey car;
 - National initiative of EPWP (extended public works project) of wheelie wagons with volunteers paid by stipends and brought to public places (f.e. community centres);
 - Book boxes like examples in Botswana;
 - Mobile library bus comparable or in cooperation with the Sapesi (South African primary education support initiative) of the department of education
 - Decentralised library hubs: hubs in remote wards which are not easily accessible and where transport to the two main libraries is difficult f.e. in cooperation with schools and department of education, community centres, traditional authorities (Nkosi's)
 - In both the examples of enlargement of the stretch of library collection: management (whereby control is an important aspect) and preparation of the project is crucial.
- o Brocadesystem:
 - o 56 libraries in KzN working in PALS system of computerisation which is no longer promoted by SITA (state information and technology agency)
 - In an international procurement CIPAL from Geel in Belgium and the Brocadesystem came out as the best and most advanced model of computerisation of collection and loaning of/in libraries.
 - The implementation in KzN is starting hopefully in the first part of 2010 in 5 pilote libraries. The next partners will be the rest of the PALS libraries in KzN.

 During jobshadowing or training it is very adviseable according to the department to give the library manager of Nquthu/Nondweni already basic training on Brocade through the library staff of Bornem (where the brocadesystem is also running since December 2009) and through Cipal. Patrick Roten from Cipal supported also this idea.

3.3. Environmental education or ecoschools

3.3.1. Preparation

Within the policy of environment that is emphasized in the memorandum of partnership and cooperation, environmental education through schools (ecoschools or MOS op school) was from the beginning one of the very visible options of cooperation within this partnership. During the two identification missions there was attention towards it through presentations, meetings and discussions.

Before actually starting this cooperation and making up an action plan for the next 2 years, a few conditions needed to be fulfilled:

- Willingness and approval of participation of schools in Nquthu and Bornem. In Bornem schools were motivated and willing to step into the exchange program. In Nquthu also though approval of the district manager of the department of education was necessary. His approval was send by a letter and confirmed by a phonecall by dr. Khanyile of the department of education.
- o Participation of relevant partners and stakeholders:
 - Direct participation of related stakeholders concerning ecoschools: DEAARD, ecoschool committees within the schools, Igemo: this willingness to cooperate was confirmed severall times during the technical mission;
 - Willingness to network towards guidance of relevant organisations on environmental education: WESSA, training centres on permaculture.

3.3.2. Meetings and field visits

Several meetings and field visits made it for both partners possible to agree on the implementation of different aspects of environmental education in schools:

- Wednesday 2nd of December: presentation DEAARD with integration of guidance of ecoschools (annex nr. 7);
- Thursday 3rd of December: presentations and field visits of Monte Cassino Primary School and Luvisini Primary School and meeting on practical implementation of the exchange program (annex nr. 8)
- Monday 7th of December: meetings and field visits on ecoschools and permaculture with WESSA to Northland primary school, Iswiliswezi primary school and Dovehouse in and around Pietermaritzburg

3.3.3. Conclusions and to do in 2010/2011 from both sides with deadlines and responsible persons

During our powerpointpresentation at the end of the visit and discussions during our visit with the responsible persons in DEAARD, Nquthu LM and the schools, there was decided to split up the ecoschoolprogram in three parts:

- 3.3.3.1. Exchange program:
 - Main goal: get to know eachother and learn from eachother through environmental education and a bit more specific waste education
 - o Which schools:
 - o In Nquthu: Monte Cassino Primary School and Luvisi Primary School
 - o In Bornem: selection of 2 primary piloteschools to participate in the exchange project
 - o Expectations of schools in Nquthu:
 - Monte Cassino: more info and expertise on waste management and environmental education
 - o Luvisi: receive positive attitude for pupils and school
 - o Content: waste education and side aspects of waste education
 - Practical organisation:
 - Work with 5th grade in Nquthu and with 5th grade in Bornem
 - Translation in English of Belgian package and in Dutch from Nquthu packages, will happen in Bornem (Belgium)
 - o From class to class exchange despite the difference in nr. of pupils per class
 - Acquaintance document will be changed in Nquthu into school profile of the ecoschool report plus extra class profile (made by Igemo)
 - Use of blog: is possible but only with help and assistance of cyber cadets in the library and with the responsible teachers and the ecoschoolcommittee. Moreover, the cadets can adapt the blog to the Nquthu context.
 - o Timeplanning
 - Teachers and DEAARD wanted to start in January but when this was not possible when it comes to organisation in Bornem
 - o Acquaintance documents is the first step January-March 2010
 - o Package 1 from Belgium: May-June 2010
 - o Package 1 Nquthu: September 2010
 - o Package 2 België: November 2010
 - o Package 2 Nquthu: jan-februari 2011
 - o Extra questions and blogcommunication can stimulate the process in Belgium and in Nquthu
 - Next steps: depending on evaluation within the schools. Further cooperation is possible from the second part of 2011.
 - o Information exchange before the start of the exchange project:
 - o To Nquthu schools:
 - Detailed planning with different stages in the exchange project (fe choose school-choose class-send acquaintance documents, look to package 1 and make package 1, ...)
 - Detailed document about the workshop in the class within the ecoschool education packages and criterias

- o To Bornem schools:
 - Add in package: surface, inhabitants, location Belgium in the world/Europe
 - Second workshop: more attention to composting because both schools in Nquthu want to start composting fe visit of school in Bornem to demo place
- o Similarities and differences schools in Bornem and schools in Nguthu:
 - Environment of kids mainly the same when it comes to playing, tv programs, etc.
 - o Cleanup campaigns in both municipalities
 - o Reason of composting is different (soil improver-reduce organic waste)
 - No sandwich boxes in Nquthu schools but there are meals from feeding scheme whereby vegetable garden is a key focus
 - o A lot of projects in Nquthu are build up around environmental thematic days
 - o Recyclable toys in Nquthu in contradiction to mass consumption in Belgium
- 3.3.3.2. Enhancement of environmental education
 - Enhancement in 3 advanced ecoschools Patsoana, Luvisi and Cassino through composting and permaculture in vegetable gardening by:
 - o Proper training on composting and permaculture
 - o Awareness and sensitization material towards composting
 - Maintainance of vegetable gardening through proper monitoring and infrastructure
 - Expansion of this project to community gardens through agricultural extension officials of DEAARD, HIV/AIDS centre garden and other interested schools through these three aspects
 - o Options for training on composting and permaculture:
 - Dovehouse Farm in Howick: 1 day training or full package of 3 days training and monitoring in Nquthu afterwards: <u>http://dovehouse.co.za/</u>
 - o Research centre DEAARD in Pietermaritzburg
 - o Research centre DEAARD in Dundee
 - o Food & Trees for Africa: http://www.trees.co.za/ in Gallo Manor

Determing the best options is the responsibility DEAARD taking different key factors into account:

- o Holistic approach on training with focus on composting
- o Integration of well contexted materials
- o Integration of sensitization and awareness
- o Integration of monitoring and follow up
- Participation of extension managers, responsible persons in the schools (teacher, gardener) and responsible person interested community gardens committees

3.3.3.3. reinforcement or enlargement of ecoschools by:

- integration of 11 schools already in the ecoschool project but in a starting stage (not advanced): relaunching these schools
- o integration of interested schools run the food security project of the department of environmental health but dit not yet step into the ecoschoolprogram

reinforce the ecoschoolproject in these schools by:

- o payment of 50% of the registration fee under condition that there is a ecoschool committee launched (one of the conditions in the ecoschoolproject itself)
- o other logistic support

The guidance and follow up needs to be the responsibility of the DEAARD

3.4. Waste management

During the reciprocal visit to Bornem in June 2009, the delegation of Nquthu got a lot of background info on the waste management and sensitization projects that are running in Bornem municipality and the neighbouring municipalities.

This inspired Nquthu LM to make a reflection concerning their own waste management and to analyse further cooperation with other waste management stakeholders in and around Nquthu. After the reciprocal visit, there was suggested that the main focus of the technical mission in December 2009 would be environmental issues and more especially: waste management and sensitization and environmental education. Therefore, Mr. Dirk Hoofd, exco-member environment of Bornem municipality, Mr. Roland Deurinck, head of the environmental service of Bornem municipality and Ms. Anneleen Vantendeloo joined as experts, this technical mission.

Waste management includes also sewage and organic waste. Because these subsections were treated under the subtitles water-and sanitation and environmental education, they are not mentioned in this section but are of course related to it.

3.5. <u>Youth</u>

3.5.1. Preparation

In the memorandum of partnership and cooperation which was signed in October 2008, youth was one of the three policy fields of cooperation.

During the reciprocal visit in June 2009 the delegation of Nquthu LM/Umzinyathi DM came into contact with the youth policy and youth in Bornem. Although youth policy is quite different from the approach in Nquthu LM, there are links possible where we can exchange information. The approach of a youth exchange was proposed by Nquthu LM at the end of the visit, this as a starting point for cooperation.

Within the short visit of Daan Sanders, official North South relations in Bornem municipality, there was the opportunity to propose the ideas of a youth exchange at the Umzinyathi district youth forum which was received positively by the forum and by the youth desk (NYDA) operating in and in close cooperation with Nquthu LM. This was the starting point for Bornem municipality to integrate youth within this technical mission supported by the participation of the youth consultant of Bornem municipality, Stefan Dekeyser and to start the selection stage of the youth in Bornem who is interested in this exchange.

3.6. water and sanitation program

3.6.1. Preparation

In the addendum of the memorandum of partnership and co-operation signed in June 2009 during the reciprocal visit, Umzinyathi DM was involved during the visit and was integrated as a close partner of Nquthu LM. Moreover the issue raised during the visit to involve the issue of the water and sanitation program of Umzinyathi DM within the technical mission or through the sending of an expert of the ex-change desk to South Africa. In August 2009 an application form of ex-change was sended to the district manager several times but due to delay, the manager of the technical department could not hand over an application before the technical mission.

3.6.2. Meetings and field visits

During the technical mission 1 day, Friday the 3rd of December, was allocated for an more extensive presentation on the bulk water supply strategy 2009-2010 of Umzinyathi DM, the water service authority for 4 LM's within the district (see annex nr. 17). Due to failures within the exploitation of the water distribution through the water service provider, Uthukela water company (an interdistrict organisation) and due to a bigger consumption of water from 1990 up till 2006 and from 2006 up till 2009, the distribution of water to all inhabitants of the district is not efficient. There is in several parts of the district a shortage of water and backlogs of drinking water production (pomping mainly for Nquthu LM area out of the rivers like Vant's drift) and distribution (supply).

After many questions that raised concerning the degradation of the relations with Uthukela water company, the possibilities of exchanging information and assistance from the side of Bornem municipality can consist in sending an expert of water supply f.e. through the exchange platform for sending out experts in different policy fields, for an assessment or proper training to detect problems of water supply (water quality control, detecting leaks or illegal tapping within the technical department of Umzinyathi DM. Contribution in funding new water plants is impossible for Bornem municipality due to the philosophy of city to city cooperation and the limited budget for different policy areas of cooperation. There are also some conditions in assisting in sending an expert through exchange:

- Application form has to be filled in by the applicant itself, namely Umzinyathi DM
- The period of assistance of the expert is limited to 2 to 3 weeks and needs to be very specific
- The accommodation costs need to be paid by the applicant.

After the application form is sended and adapted to a specific demand, the search can start.

During the early afternoon there was a field visit to the biggest water plant in the region around Nquthu LM, Vant's Drift, still under operation of Utugela Water Company, an interdistrict water company which operates in different plants in the region. After a clear

guiding tour of one of the employees of Uthukela water company, the delegation could detect already with their own eyes though not fully experienced into water supply, problems within the plant when it comes to leaks, pumps that don't function properly, etc.

During the same visit a first meeting with Raymond Nazar, consul of Belgium in Durban, was organized which opened perspectives of a possible cooperation around more experienced FET colleges in urban areas and rural starting FET colleges (f.e. Amajuba FET college section in Nquthu LM).
